**RESOLUTION ESTABLISHING INTENTION TO  
ACCEPT OWNERSHIP AND MAINTENANCE OF ROADWAY**

**WHEREAS**, Recreational Realty, Inc. and Stephen Mauro being the owners of SBL 149.1-2.12, said parcel having been recently annexed into the City of Gloversville and said parcel being generally located on the westerly side of State Highway 30A near its intersection with Steele Avenue Extension; and

**WHEREAS**, the City is currently progressing a break-in access through the New York State Department of Transportation for the connection of a proposed new roadway from New York State Route 30A into SBL 149.1-2.12; and

**WHEREAS**, the City is required to own the new roadway that will be constructed to create the new aforementioned intersection (break-in access); and

**WHEREAS**, the parties have agreed that following satisfactory completion of said improvements, Recreational Realty, Inc. and Stephen Mauro will offer the roadway and its associated right-of-way for dedication to the City of Gloversville.

**NOW, THEREFORE**, be it hereby

**RESOLVED**, that it is the intention of the City of Gloversville to accept ownership and maintenance of said roadway upon the satisfactory completion and dedication of the roadway and associated right-of-way.
